- 1. SWEEPSTAKES PERIOD/ ENTRY PERIODS/PHASES:** The Sweepstakes begins at or about 12:00 PM Eastern Time ("ET") on May 20, 2024 and ends at 11:59:59 PM ET on September 2, 2024 ("Sweepstakes Period").

Entry Periods: The Sweepstakes Period is comprised of five (5) Entry Periods (each, an "Entry Period") and one (1) grand prize drawing entry period (the "Grand Prize Entry Period") as set forth below:

Entries submitted in an Entry Period **do not** carry forward to subsequent Entry Periods. All valid entries into the Sweepstakes for any Entry Period will be included in the Grand Prize drawing as set forth in Rule 4, provided that if an entrant wins a First Prize (as defined in Rule 5) then he/she/they is not eligible to win the Grand Prize (as defined in Rule 5).

The Sweepstakes is subject to all federal, state, and local laws and regulations.

The Administrator's computer is the Sweepstakes official clock.

- 2. ELIGIBILITY:** This Sweepstakes is offered only to legal residents of the fifty (50) United States and the District of Columbia who are at least twenty-one (21) years old at the time of entry

and have a valid U.S. driver's license or government-issued photo ID. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes.

If more than one (1) entry per day is received from the same person, telephone number, or e-mail address, only the first entry received may be considered valid. Each entrant must submit an entry on his/her/their own behalf. Any entry submitted on behalf of another individual or using another person's email address, name, or mobile phone number will be disqualified and ineligible to claim any prize. Any attempt by any entrant to obtain more than one (1) entry per day using multiple e-mail addresses, identities, or any other methods will void such entries, and that entrant may be disqualified. 4. **RANDOM DRAWINGS:** On or about each of the Random Drawing Dates set forth in Rule 1, the Administrator will randomly select the associated number of potential "First Prize" winners, as that term is defined below in Rule 5, for the applicable Entry Period from among all eligible entries received during the applicable Entry Period. On or about September 3, 2024, the Administrator will also randomly select five (5) potential "Grand Prize" winners, as that term is defined in Rule 5, from among all eligible entries received during the Grand Prize Entry Period. Each winner is considered a potential winner pending verification of his/her/their eligibility and compliance with the Official Rules.

- C. Entry Period 2 First Prizes (140):** Each “Entry Period 2 First Prize” is a Mana BBQ Tool Set. No more than one hundred forty (140) Entry Period 2 First Prizes will be awarded in the Sweepstakes. The ARV of each Entry Period 2 First Prize is \$50.
- D. Entry Period 3 First Prizes (150):** Each “Entry Period 3 First Prize” is a Teremana Duffel Bag. No more than one hundred fifty (150) Entry Period 3 First Prizes will be awarded in the Sweepstakes. The ARV of each Entry Period 3 First Prize is \$60.
- E. Entry Period 4 First Prizes (150):** Each “Entry Period 4 First Prize” is a Teremana branded shakers. No more than one hundred fifty (150) Entry Period 4 First Prizes will be awarded in the Sweepstakes. The ARV of each Entry Period 4 First Prize is \$10.
- F. Entry Period 5 First Prizes (150):** Each “Entry Period 5 First Prize” is a Teremana Bottle Pool Float. No more than one hundred fifty (150) Entry Period 5 First Prizes will be awarded in the Sweepstakes. The ARV of each Entry Period 5 First Prize is \$20.
- G. Total ARV:** The total ARV of all available prizes in the Sweepstakes is \$22,750
- H. Odds of Winning:** The odds of winning a First Prize depend on the total number of eligible entries received during the applicable Entry Period. The odds of winning the Grand Prize depend on the total number of eligible entries received for the entire Sweepstakes Period.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN NEW YORK. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN NEW YORK COUNTY, NEW YORK. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
